

Admissions Process for International Students:

- Complete the online application for admissions at www.flprep.com and submit the \$100.00 USD application fee.
- Send Request for Records Form and submit the three recommendations.
- Signed and initialed Fee Schedule
- Submit a copy of the applicant's academic transcript translated into English. (A translated official transcript is needed prior to arrival.)
- Submit a color copy of the first page of the applicant's passport showing the number, country of birth, country of citizenship and the passport expiration date.
- International students entering Florida Prep must submit English proficiency testing. The TOEFL iBT is required if you are an International student or if your primary or fluent language is not English. To register for the TOEFL iBT or TOEFL Junior, visit http://www.ets.org/toefl. When registering, select "Undergraduate" for school type and list Florida Prep school code 9049 so an official score report will be received by Florida Prep. If TOEFL testing is not available, additional standardized testing is required, such as iTEP, IELTS, ISEE or PSAT or other English Proficiency test.
- Provide the name, address and telephone number of a personal contact in the United States, in case of emergency.
- Upon review of the applicant's information, Florida Prep will notify the applicant of acceptance.
- A non-refundable \$2,800 registration/international fee must be forwarded to Florida Prep upon acceptance for the I-20 issuance. Please contact the admissions office by e-mail at admissions@flprep.com to obtain the wire transfer information.
- If accepted, the applicant will be issued an acceptance letter, SEVIS 1-20 form and a physical examination form and immunization record to be completed by the family physician.

Requirements Upon Admission:

- Obtain an affidavit of support from the parents/guardians bank showing sufficient funds to cover the cost of the education. This is actually needed at the Embassy interview.
- Once the I-20 is received and prior to the VISA interview, you must take care of the I-901 fee. Visit www.fmjfee.com/i901fee for the SEVIS I-901 Processing website or for further information contact SEVP at (US) 1-703-603-3400.
- Schedule an appointment for an interview at the nearest US Embassy to obtain a VISA. The applicant must provide the Sevis I-20 form, the affidavit of support and the academy's acceptance letter to the embassy official. The student must be able to express his or her desire to study abroad to prepare for college during the ten-month period school is in session. The applicant must also agree to return home to their family and country at the end of the school year.
- Once approved by the US Embassy, notify the admissions office and you will be given date and time of arrival in the United States to begin studies at Florida Preparatory Academy. Students are expected to arrive on campus by the designated date on the I-20.
